### **Albany NH Selectmen's Meeting**

**May 19, 2010**

At 4:00 p.m., the Selectmen's meeting was called to order. In attendance were Jack Rose, Sara Young-Knox and Joe Ferris. Rita Wells was also present. The following business was conducted.

#### **Regular Business:**

- Reviewed & approved May 12 minutes—Jack motioned to approve minutes as submitted, Joe seconded and all were in favor.
- Signed checks totaling \$6,728.56
- Reviewed & approved one building permit
- Reconsidered a denied building permit—Sara motioned to reconsider a building permit that was denied on May 12 submitted by Kenneth and Susan Sullivan, Jack seconded the motion and all were in favor. Joe motioned to table the application in order to ask the Planning Board for an advisory opinion of the ordinances. Sara seconded the motion and all were in favor.
- Reviewed & approved one sign permit
- Reviewed & approved two pistol permits
- Reviewed & signed letter to White Mountain National Forest
- Reviewed & signed letters regarding violations
- Reviewed letter from NH Charitable Foundation
- Reviewed letter from Tin Mountain Conservation
- Reviewed letter from Peter Malia regarding Hearing of Merits
- Reviewed e-mail from Earl Sires
- Reviewed letter from NHDES regarding lifting Boil Order at Lower Falls Scenic Area

#### **Land Governance Board:**

Jack informed the Board that the Scenic ByWay Grant application has gone to Washington D.C. for the next step of approval. He noted that our application is #2 of 5. He is not sure when a decision will be made.

#### **Miscellaneous:**

The AA will continue to research the RSA's and draft letters for the Board to sign and send out violators in order to bring Albany into compliance with its own ordinances and state laws. Jack would like the next set of letters mailed

Joe asked about subcontracting out the task of administering welfare. The AA informed him that it had been voted down at town meeting a few years ago. Joe volunteered to look into it. Sara made a motion to look into the feasibility of hiring out the welfare administration. Jack seconded the motion and all were in favor.

Joe noted that if it was required to have an ordinance to insist that loggers post a bond in order to protect the town's roads, then the Board should work on it now so it may be voted in at next year's town meeting.

At 5:20 p.m., Jack made a motion to adjourn, Joe seconded the motion and all were in favor.
