# Amended Minutes Albany NH Selectmen's Meeting 

April 7, 2010
At 3:00 p.m., Jack Rose, Sara Young-Knox, Brian Taylor and the Administrative Assistant drove through Tabor Circle, Wildwood Rd., Brookside Ave., Cranmore Shores Rd., Bridge St., Drake Hill Rd. and Old Colony Rd. The purpose was to search for health violations such as unnecessary debris in resident's yards. Letters will be written to violators.

At 4:00 p.m., the regular Selectmen's meeting was called to order. In attendance were Jack Rose, Sara Young-Knox and Joe Ferris. Curtis Coleman joined the meeting at 4:20 p.m. The following business was conducted.

## Curtis Coleman (Road Agent):

Jack asked Curtis what his road maintenance plans were for the spring. Curtis replied that Moat View Dr. will be crack sealed then sealed and Red Eagle St. will be sealed. He reported Drake Hill Rd. and Chase Hill Rd. have been graded and gravel will be added to Chase Hill Rd. soon. Then the culverts will be maintained. Gravel will be added on the shoulders of Bald Hill Rd. Curtis went on to say that the drainage on Tabor Circle and Wildwood Rd. is poor. He is waiting for PSNH to decide what their plan is to fix electrical problems in the area as the lines are underground. Curtis plans to add gravel and grade Wonalancet and would like to do extra sealing on Old Colony Rd., Drake Hill Rd. as well as crack seal Bald Hill Rd. while sealing part of it.

Sara stated that the Forest Service is planning to do a lot of logging and voiced her concern on the effects of trucks causing damage to the roads. Joe asked if the town could possibly make the logging companies post a bond for any damage done to the roads while logging. Curtis said the logging companies have never been required to post a bond before and didn't know if the town could insist on the bonding. Joe will look into bonding of the town roads. Sara stated most of the logging will occur in the winter while the roads are frozen. Curtis replied the roads would fare better in winter. Sara suggested that the AA reply to the property owners who e-mailed their concerns for the roads to let them know of the town's intentions.

Jack asked Curtis if Passaconaway Rd. and Bald Hill Rd. should be striped in order to prevent accidents on narrow areas and corners. Sara did not think it would help. Curtis agreed with Sara.

At 5:02 p.m., Sara made a motion to adjourn, Joe seconded the motion and all were in favor.
