Albany NH Selectmen's Meeting March 24, 2010

At 4:00 p.m. the Selectmen's meeting was called to order. In attendance were Jack Rose and Joe Ferris. Also present were Rob Nadler, Harry Richardson and Brian Taylor. The following business was conducted.

Regular Business:

In order to stay in compliance with RSA 673:7, Rob Nadler submitted his resignation from the Planning Board in order to keep his position on the Land Governance Board. Jack made a motion to accept Rob's resignation, Joe seconded the motion and all were in favor. Jack made a motion to nominate and appoint Sam Farrington to the Planning Board, Joe seconded the motion and all were in favor. Jack made a motion to appoint Rob Nadler as Albany's representative to the North Country Council, Joe seconded the motion and all were in favor. Rob accepted the nomination.

Brian Taylor (Health Officer):

Brian has contacted Rick Treiss of NHDES. Rick could not attend the Selectmen meeting but called in during the meeting. After Jack spoke on the phone to Rick Treiss, a meeting has been scheduled for Tuesday, March 30 at 10:00 a.m. to inspect certain areas of the town with potential health problems. Brian will also invite Louise Hanlon of NH Department of Health and Human Services. Brian told the Board he would like to come up with a procedure for dealing with problems and create continuity for the whole town, not just one portion.
