Next Meeting: It was decided that the next meeting will be at the call of the Chairman.

- Other Business: Discussion on whether the Town should purchase telephone conference unit with microphones, and a service to facilitate a meeting conference due to the COVID-19 emergency declaration and abiding by the NH RSA 91A regarding meetings and the NH Attorney General recommendations. It was mentioned that the unit would cost approximately \$284, the extra microphones at \$133, and the conferencing service would run approximately \$12 -\$20 per month. Selectman Ferris recommended the PolyCom 2 unit as he has used this particular unit at work, and it works well. Selectman Ferris made a motion to authorize the Chairman to purchase a PolyCom 2 conference unit with 2 additional microphones and a conferencing service to facilitate conference calling not to exceed \$600, seconded by Selectperson Ryan and a roll call vote was taken, and all were in favor.
