D. Review, discuss and approve Conway Area Humane Society Annual Agreement for Services

TA notes that she assumes this contract has already been vetted by Primex as the Board signed it last year. Chairman Hiland asked the TA to send it to Primex for review.

5. Town Administrators Report:

- A. Review 2021 budget & warrant for discussion at Budget Public Hearing The Town Administrator assumes that the Board may want to run through the budget and warrant one more time before the public hearing this evening. The Board noted that they were all set with the budget and warrant as preseted,
- <u>6.</u> <u>APPOINTMENTS:</u> Meet with Moderator, Edward Alkalay, to review and discuss time and place of Town Meeting

Mr. Alkalay has Covid 19 issues that need to be addressed. Mr. Alkalay feels the best thing for the town is to keep things the same. Due to Covid, 2 weeks ago Mr. Alkalay reached out to Kevin Richards about using the Kennett Middle School for Town Meeting. The Town of Conway is willing to make the Marshall Gymnasium available to us. Of course, there are safety concerns but even with 100 people we could safely distance in either of those venues. There are all kinds of practical problems with doing it outdoors. His opinion is that we should go forward on March 9, or March 10 at Kennett Middle School or the Marshall Gymnasium.

Chairman Hiland noted that the Selectmen have not discussed this at all, we have been working on the budget and the warrant.

Selectman Ferris is concerned with contracting the virus. If we can safely distance and keep the meeting to a reasonable time, he doesn't see any reason we couldn't have it at the Gymnasium.

Selectman Zeiders is concerned about being in a room with 100+ people breathing re-circulated air. He has not been to a restaurant since last January.

Town Clerk/Tax Collector, Cathy Ryan kind of waffles on this, she doesn't have a strong opinion on this, but is wondering how many people would not feel comfortable coming to the meeting and therefore would not be willing to participate. C. Ryan is getting the feeling that there are a couple of hot issues that will extend the duration of town meeting. She is a little bit on the fence.

Chairman Hiland originally was ok with it, but since then the Town has received a couple of petition articles that may increase the attendance. He is not comfortable sitting in a room with 80, 90, or 100 people for hours, breathing the same air. He is not a big fan of masks. He and his family have avoided a lot of things in the last 10 or 12 months so they don't get the virus. He is not sure he would be willing to attend a meeting. He has

considered the possibility of moving the meeting to April, May or June with all the windows open or outside. He does not intend to attend a meeting in a closed room. The Governor's Executive Order #83 and HB 1129 all layout how we may postpone the town meeting process. As far as the election is concerned, he doesn't feel there will be a big turnout and we conducted 4 elections, successfully, last year.

Ed Alkalay so just a couple of rejoinders. Ed spoke to Tim and the school chose to go ahead. So that would mean 2 meetings for the people in town. We need to do the best we can. He thinks we can make it safe. We can have temperatures taken and screening forms done. The schools have been operating like this for a long time.

Selectman Zeiders notes that the school is operating in small groups of 10 in a cohort. He thinks the use of the room will still be available in April or May and more people will have been vaccinated and hopefully the rate of infection will drop off a little.

Selectman Ferris says this sounds reasonable to him. He would be surprised if there were 100 people at the meeting but we have to assume that there will be a large turnout. He thinks for the sake of the people it would be safer to put it off.

John Eastman's question is what does this do with some of the services that we pay for. Either for the budget or the warrant article?

TA noted we would only be able to pay for fixed expenses.

John Eastman asked if we would consider extending funding for parks and recreation through the budget. Spring programs start around April so this could potentially shut Albany kids out of the spring programs.

Curtis Coleman – that cannot happen. This Board would totally neutralize sports for these kids until 7th grade. This Board needs to address this right now. A lot of people in this Town are concerned. The Board needs to address this right now.

Catelyn Quint is a parent of two kids that participate in the recreation programs. It is very important to these young children to have the ability to participate in these programs.

Kathy Golding's point of view is that Conway is still planning on having their deliberative session in a safe manner. She doesn't understand why the Town of Albany cannot do their meeting.

Rick Timsilicki, when does the Board intend to make their decision about town meeting. We have a meeting for the school board and we have to let them know. He is inclined to stick with the date and does not like the leaders in Albany reacting from a position of fear. What if nothing has changed between April and May will you put it off until September? He thinks the town and school meetings should be done together. It should be done on sound arguments and the reasons you have given are not it.

Selectman Ferris asked if there is a way to spend money on these services? The TA said the only way to do this would be to have trust on both sides. The

BOS would have to trust the people who brought the petition to amend the amount down and the people would have to trust the BOS to put an amount in the operating budget to get them through the Spring sport season. This is what Selectman Ferris is interested in. Selectman Ferris notes that it definitely hurts the selectboard when people put in warrant articles like this. Selectman Ferris believes this will pass at town meeting

John Eastman has a couple of things to set the record straight. He does not believe the knees of the selectman were cut out from them. John Eastman agreed with some things that Chairman Hiland found. John Eastman doesn't personally have a stake in this as his kids are grown. There is a large degree of uncertainty. When the Board hasn't decided if it isn't in the budget or not. It doesn't fly with Albany voters. That is why there was a petition put together. It seems quite apparent that it wasn't going to make it into the budget. The Town of Conway may have negotiated as much as they can. The Town of Albany should not over play it's hand. Mr. Eastman noted he is fiscally conservative but we don't have a lot of service in Albany. You don't need to have faith. The people of Albany are good people and work hard. He won't speak for the town manager but it seems like Conway has negotiated as far as they can.

Chairman Hiland noted that Mr. Eastman's statement is not correct. The P & R amount provided by the Finance Director in Conway was in the operating budget. The petition warrant article was received on Wednesday, January 27, 2021 and that is the night the budget item was zeroed out. The Board felt it had no choice so that it would not be appropriated twice.

Curtis Coleman we have been adjusting warrant articles on the floor of town meeting forever. The Board could put it back in the operating budget. For \$43K we are getting a great service. For all intents and purposes we are part of Conway with better taxes and less government. We are spinning our wheels on this thing when we don't need too. Leaving the kids in peril or unknown isn't fair. Kids are the least affected by Covid but more affected by some of it.

Selectman Zeiders supports the recreation portion of this and there was never any intent to cut this off.

Ed Alkalay's understanding of why this was placed as a petition warrant article is because when he specifically asked Chairman Hiland about this, Chairman Hiland said he was only one selectman and he couldn't answer this. So that is why the warrant article was put in there.

Selectman Ferris made a motion to put the P & R money back into the budget. Selectman Zeiders seconded.

Discussion: Cathy Ryan as a citizen as an average lay person that you heard there were negotiations going on. When I put on my former selectmen's hat I want to commend the selectmen for all the work they did on this. (with the library since August) Now that we have 2 warrant articles she can see why you would zero out these line items. As a resident she views it as the

community of The Valley. We should support The Valley. She doesn't' mind paying for the parks, it is part of living here, she gets to use them 24/7. As an Albany resident I don't mind paying that money. She thinks recreation is really important.
