6. Old Business:

A. Review, discuss and finalize the proposed 2022 Budget and Warrant for the February 2, 2022 Budget Public Hearing

The Board reviewed WA 11, 13, 14, 15, 16. These are the petition warrant articles that have been submitted since the Board's last meeting and therefore need a vote on recommending or not recommending. Chairperson K. Golding made a motion to recommend WA 11, 13-16. Selectperson J. Spofford seconded. Motion passed: 3-0-0.

Chairperson K. Golding brought up using Valley Vision for recording the Town's Board/Committee/Commission meetings. It would be \$60 per meeting for a videographer. There are twenty-four Selectmen's meetings per year, twelve Planning Board meetings, twelve Conservation Commission meetings and we will budget for twelve School Committee meetings (although they generally do not meet during the summer). That gives us a little wiggle room for any additional meetings of these bodies or whatever Zoning Board of Adjustment meetings they would have. This would be \$3600 for the year. The Board will make that change to the operating budget line item 4150.38 meeting video from \$3000 to \$3600.

The Board increased 4150.38 Meeting Video by \$600 to \$3,600. Library moved from Warrant back to operating budget. We encumbered some tax deeding legal funds in 2021.

Chairperson K. Golding went through some of the budget items.

Operating Budget is amended to \$751,483. This is \$4,515 less than 2021

The Warrant Article this year, including all petition articles total is \$192,823.
