Chair K. Golding made a motion to encumber the following funds from 2022 into 2023:

Matching funds for LHMP update (Emergency Management 4290.04) in the amount of \$5,833

Annual Alarm Maintenance (Town Hall Security 4194.09) in the amount of \$643.50)

Selectman K. Robitaille seconded. Motion passed: 3-0-0.

B. Review and discuss recommendation to budget \$15,000 under tax deeding/legal and use 12/31 fund balance to offset this amount as it was encumbered from 2021 to 2022 and still unexpended. May want to consider doing the same with some part of the Chapel encumbered legal fees

The Town Administrator noted that based on preliminary emails with the Town Attorney she thinks we should definitely budget the \$15,000 for Legal/Tax Deeding and then offset it with \$15,000 in revenue from December 31, 2022 unassigned fund balance as that amount will drop into unassigned fund balance because we encumbered it from 2021 to 2022 and did not expend it.

The Board of Selectmen reviewed the letter to be sent, approved and signed the ten letters to owners whose property they took by tax deed for non-payment of 2019 taxes.

The Town Administrator got an estimate for printing of checks. We will need them sometime in 2023. A quantity of 500 is \$821 without shipping and a quantity of 1000 is \$1031 without shipping. The Board approved the TA purchasing check from 2022. She noted she would send the order tonight, before she leaves.
