

# Albany Selectmen's Meeting Minutes



# Albany, New Hampshire March 8, 2023 at 5:30 p.m.

1. Call to Order: Chair K. Golding called the meeting to order at 5:30 p.m.

Chair K. Golding made a motion to approve the minutes of the February 22,

# B. Review and discuss alleged zoning violation on Passaconaway Road

The TA noted that she has received complaints about the number of people residing at 1510 Passaconaway Road, including statements from Deputy Sheriff Rowe noting that at least (2) campers/recreational vehicles are being used as residences and that numerous people living in the house. The TA noted that this same resident was cited in 2020 for similar zoning violations and she has prepared a letter to the owner from the Board and the Town Health Officer.

Chair K. Golding made a motion to approve and sign the letter to the owner of 1510 Passaconaway Road regarding alleged zoning violations. Selectman K. Robitaille seconded. Motion passed: 2-0-0. Note: The Health Officer: J. Ferris has already reviewed, approved and signed the letter.

C. The Town Administrator made the Board aware that she has received an email from resident, Rick Hiland, expressing interest in serving as a member of the Zoning Board of Adjustment (ZBA).

Chair K. Golding made a motion to appoint R. Hiland as a full member of the ZBA. Selectman K. Robitaille seconded. Motion passed: 2-0-0.

The Board reviewed the notice from Charter regarding  $4^{th}$  Qtr 2022 franchise fees.

B. Review and discuss letter from NH DOT listing next 65 bridges that will be funded over the next ten year plan process.

The Board reviewed and discussed the letter from NH DOT regarding the list of the next 65 bridges that are listed for funding over the next 6 – 10 years. The Town Administrator and Board are disappointed and confused over why Albany's Drake Hill Road bridge is not in the 65 bridges slated to receive DOT funding over the next 10 years. The TA did contact NH DOT's C. R. Willeke and was told that Albany's bridge is ranked 121 out of the remaining 179 bridges. He also noted that this is because the bridge only has one 4 rating and other bridges are in much worst shape.

The TA reminded the BOS that we do have the \$45K in one-time additional bridge aid that the Road Agent must use on bridge repairs and/or maintenance.
