1. Call to Order: Chair J. Spofford called the meeting to order at 5:30 p.m.

A. Approval of April 12, 2023 Selectmen's Meeting minutes, including (2) sets of sealed Non Public minutes

C. Review and discuss Joseph Ferris' email interest in serving as Deputy Health Officer for Albany

The Board reviewed the email from former Albany Health Officer, Joe Ferris, expressing his interest in serving as the Deputy Health Officer. Selectman K. Golding also expressed interest in serving in this capacity and is willing to waive the Deputy stipend.

Selectman K. Robitaille made a motion to nominate Kathleen Golding as Deputy Health Officer for Albany. Chair J. Spofford seconded. Motion passed: 3-0.0.

Selectman K. Golding made a motion to pay Health Officer, David Pandora monthly at \$100 per month and she will waive the deputy pay. Selectman K. Robitaille seconded. Motion passed: 3-0-0.

The Town Administrator reminded the Board that the 2023 budget for health officer is \$600 annually and for deputy health officer the 2023 budget is \$500 annually.

D. Review & discuss 2023 Lien

The Board reviewed and discussed the 2023 lien. The TA noted the lien is up about \$5000 from last year, but still considerably lower than 2020 or 2021.
