1. Call to Order: Chair J. Spofford called the meeting to order at 5:30 p.m.

- 2. Pledge of Allegiance: Chair J. Spofford led The Meeting in The Pledge.
- 3. New Business:
 - A. Approval of September 6, 2023 Selectmen's Meeting minutes Chair J. Spofford made a motion to approve the minutes of the September 6, 2023 meeting, as presented. Selectman K. Robitaille seconded. Motion passed: 2-0-1

6:00 p.m. Meet with James Innes/USDA Forest Ranger and Road Agent, Curtis Coleman to review and discuss two projects in Albany: 1) the Sandwich Vegetation Management Project and 2) a fuels reduction project off High Street

The Board met with Road Agent, Curtis Coleman and District Ranger, James Innes to review and discuss two projects in Albany, as stated above.

For the first project, the Sandwich Vegetation Management Project, one area is off the Liberty Trail and one is off the Ferncroft trail head. The timber sale for this project would likely happen in 2026. Road Agent, Curtis Coleman, had question about dust on the Ferncroft trailhead, and noted that the bridge is in good shape. C. Coleman would like to see calcium chloride applied every 6 weeks of the project. Road Agent noted that the town will have a big problem if the Federal Government tries to haul on Passaconaway Road. They used to put in a temporary bridge and haul if off the Kanc.

For the second project, the fuels reduction project off High Street – there will be some timber removal and it will be High Street and hauled out on High Street. They will try to get the beech and undergrowth out of there so if there is a wild fire there is room to fight it. This project probably won't be approved for at least another year, could be 2025.

There is a section of High Street that is paved and C. Coleman noted that the Town would not re-pave until after this cut is done.

6. Old Business:

- A. Chapel/Historical Society Town Attorney has filed with the Court for the clearing of the Chapel deed of restrictions
- B. NH DOT Project 29597 NH Rte 16 review and discuss submission from DOT (meeting with DOT tentatively moved to 10/25/2023).

 The Selectmen would like to see both North Country Council and local State Representatives involved in this project.

- A. Planning Board Selectman K. Robitaille There was a meeting last week with Saco and Swift Rivers Advisory Committee and Albany is doing more than what most other towns are doing. They would be concerned with any new construction close to the river(s)
