



Albany Selectmen's Meeting Minutes

1. Call to Order: Chair K. Robitaille called the meeting to order at 4:30 p.m.

<u>In Attendance</u>: Chair K. Robitaille, Selectmen J. Drouin and R. Hiland, Town Administrator K. Collins and Videographer L. Slitt.

2. Pledge of Allegiance: Chair led the meeting in The Pledge.

3. New Business:

A. Approval of April 24, 2024 Selectmen's Meeting minutes, including (1) set of Non Public Minutes and (2) sets of sealed Non Public Minutes

Selectman R. Hiland made a motion to approve the minutes of the April 24, 2024 Selectmen's Meeting and (3) sets of Non Public Meeting minutes. Chair K. Robitaille seconded. Motion passed: 3-0-0.

- B. Approval of May 8, 2024 consent file
 - __Review & Sign manifest(s) in the amount of \$2,598.60, 5,303.69 and \$46,236.25 this includes an accounts payable and payroll manifests for 4/30, 5/1 and 5/8/2024
 - __Review, discuss and approve/deny residential building permit for single family home with 2 car garage at Map 9, Lot 139
 - __Review, discuss and approve/deny residential building permit for repair/replace bunkhouse at 46 Johnson Road, Map 11, Lot 29

Chair K. Robitaille made a motion to approve the consent file for discussion. Selectman R. Hiland seconded.

Discussion: Selectman R. Hiland would like to table the building permit for the bunkhouse repair/replacement at 46 Johnson Road and ask the owner to attend a selectmen's meeting. It appears that the building permit issued in 2020 for replacement of a 24x16 shed is actually a cabin Selectmen R. Hiland made a motion to amend the motion for approval of the consent file with an approval of the manifests and the Map 9, Lot 139 building permit and table the 46 Johnson Road building permit until such time as the town can meet with the owner for clarification and TA will talk to Town Counsel and NH DES. Selectman J. Drouin seconded. **Amendment passed: 3-0-0, Motion passed: 3-0-0.**

C. Review, discuss and approve/deny request for Charitable Exemption under RSA 72:23-V for Mount Washington Valley Habitat for Humanity (see Assessor's recommendation)

Selectman J. Drouin made a motion to approve for discussion the MWV Habitat for Humanity

Charitable Exemption due to the fact that while they own and may partially occupy the property they are not currently using it for their mission. Chair K. Robitaille seconded.



Selectman R. Hiland made a motion to amend to original motion to deny the Charitable Exemption. Selectman J. Drouin seconded. Amendment passed: 3-0-0. Original motion failed 3-0-0.

D. Review, discuss and vote on closing out the US DOT FLAP grant project for Passaconaway Road

Chair K. Robitaille made a motion to close out the US DOT FLAP grant as we cannot do the project when it requires a long closure of Passaconaway Road. Selectman R. Hiland seconded. **Motion passed: 3-0-0.**

E. Review and discuss possible dates for a Special Town Meeting to correct defects to the 2024 Warrant

The Town Administrator needs some dates for the Special Town Meeting so that she can clear this with the Moderator and Supervisors of the Checklist. The Board chose June 26 or July 10.

F. Review, discuss and re-consider Veteran's Tax Credit

The owner has requested that the selectmen reconsider their decision to prorate the Veteran's Tax Credits in accordance with RSA 72:30

Selectman R. Hiland made a motion to rescind original vote of 50% due to fractional ownership and give him the 100% of both the Optional Veteran's Tax Credit and the Disabled Veteran's Tax Credit. Chair K. Robitaille seconded. Motion passed: 3-0-0.

G. Review, discuss and complete application for Town credit card thru Bank of NH

The Board reviewed, filled out and signed the application for a new town credit card. Selectman R. Hiland made a motion to increase the credit limit with the new application to \$1500. Selectman J. Drouin seconded. Motion passed: 3-0-0.
