    The BOS and TA discussed a deadline of October 1, 2025 for all Boards and Committees to submit their preliminary budgets to the TA. Road Agent C. Curtis advised the Board that his budget will have an increase of \$8,000.00 to accommodate for the rising costs of goods and services with approximately \$4,000.00 towards winter road maintenance and \$4,000.00 towards summer road maintenance. Conservation Commission member J. Ryan advised the Board that the C.C. budget will remain the same as last year.
