

NOTICE OF PUBLIC HEARING

ALBANY Project #45056; X-A005(660)

Under NH RSA 230:14 and Public Law 100-17 (Surface Transportation and Uniform Relocation Assistance Act of 1987), a public hearing has been set to discuss the proposed improvement to the NH Route 16 and Nickerson Road intersection safety. This project proposes widening the intersection of NH Route 16 and Nickerson Road in Albany to add a southbound left turn lane, beginning approximately five hundred feet south and ending approximately one thousand feet north of Nickerson Road. In addition to widening NH Route 16, the project will improve the Nickerson Road approach, reconstruct an existing culvert, as well as improve drainage and grading conditions throughout the limits.

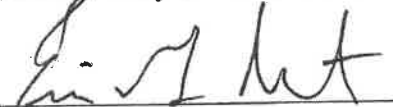
The NH Department of Transportation will conduct a public hearing to determine whether there is an occasion for the laying out of this project and acquiring necessary rights-of-way. A Commission of Three Persons will be appointed by the Governor and Executive Council to conduct the hearing.

Interested landowners, local officials, and highway users are invited to attend the hearing and will have the opportunity to express their comments relative to the project. Audio of the hearing will be recorded. Maps, plans, environmental studies, and other pertinent information developed for the Department, along with written reports received because of the coordination with other agencies, are available at the Department of Transportation at the John O.
